The seller shall at all times and without notice be entitled to enter the premises believed to be occupied by the purchaser without any liability for trespass and recover there from the equipment being subject of this agreement but only if there is then an existing default in the terms of payment for such equipment.
 - d. The sale by the purchaser of any equipment prior to payment in full of the moneys due thereon shall be made by the purchaser as the seller's agent and the purchaser shall forthwith account to the seller for the proceeds of sale to the extent to which such proceeds are necessary to satisfy moneys due.
